Recital Costumes are \$90 per dance (2 in 1 costumes are \$135) **due November 1, 2021**. If you do not pay for your costume it will not be ordered and your child will not be permitted to perform in the recital. You are responsible for any late, rush or shipping fees for costumes payments received after the original order is placed. Recital fees are \$65 first child and \$20 for each sibling **due Feb 1, 2022**. The recital fee covers: 1 recital t-shirt, end of year medal, & 1 video of your recital.

ADA has a no refund policy. Tuition is due the first day of each month/session. **A \$10 late fee will be charged if tuition is not received by the 10<sup>th</sup> of the month/session-NO EXCEPTIONS**. The fee for returned checks is \$35. If your account becomes more than 90 days late and legal action is taken, you will be required to pay any and all attorney fees related to your case/account.

Class placement is entirely at the discretion of the director. When classes are missed due to snow days or illnesses they can be made up in appropriate age and level classes. No refunds granted. There will not be any make up classes offered after May 1 due to recital preparation.

I have read and understand ADA's Studio Policies, Rules and Payment Schedules. I understand that tuition will not be refunded and there will be no credit given for classes dropped. I understand that there are additional costs to participate in the recital such as costumes, recital fees, and tickets.
